On the east dock, the applicants propose to reconfigure an existing twelve (12) foot wide by twenty-four (24) foot long float, install two (2) six (6) foot wide by twenty (20) foot long floats, two (2) ten (10) foot wide by twenty (20) foot long floats, two (2) twelve (12) foot wide by twenty-four (24) foot long floats.
