Chairman Tomko called the Board of Selectmen's Meeting to order at 7:00 p.m.

Pledge of Allegiance: The Board of Selectmen and members of the audience.

Introductions of the Board of Selectmen.

Chairman Tomko asked for a motion to act on the contract for Julia Latter as our new town manager. Motion made and seconded. Approved 5-0.

Chairman Tomko asked for a motion to appoint Julia Latter as Town Manager, Tax Collector, Treasurer, Agent for Overseer of the Poor, and Public Access Officer. Motion made and seconded. Approved 5-0.

TOWN MANAGER'S ANNOUNCEMENTS:

- 1. The town office will be closing Thursday, November 14th at 3:30 p.m. for required annual training that all administration staff will be attending.
- 2. The town currently is still taking applications for the budget committee. Applications are available online or at the town office. The first budget meeting is the 11th of December. Applications will be brought to the board on the 25th.
 - a. Asking the board to formally accept the resignations for John O'Connell and David Profit from the Budget Committee. Motion made and seconded. Approved 5-0.
 - b. Asking the board to formally accept the resignation for Robert Hilscher from the Board of Appeals. Advertisement for this position will be done. Motion made and seconded. Approved 5-0.
- 3. November 14th is Open Night of Gardens Aglow and that evening we will be turning on all the lights in town as well for Boothbay Lights.
 - a. Chair Tomko announced Gardens Aglow will be running from November 14th through December 31st. The town will be lit up and expecting a great number of visitors.
- 4. Code Enforcement Officer Smith and Town Manager Latter will be meeting with Firefly Monday afternoon to discuss site development and to create a platform for not only Museum in the Streets but other tours that would be interested as well. That information will be available at an upcoming meeting.

5. Chair Tomko asked if there is an update on Cody Mitchell from BRTV regarding the Live Video Conference System. Town Manager Latter said she has called and left messages and has had no response, but will continue to reach out.

SELECTMEN REPORTS:

- 1. Chairman Tomko thanked Don Gerrish and all of the candidates regarding the town manager search. Tomko thanked the board for their work and is very proud with the way things turned out.
- 2. Chairman Tomko mentioned how proud he was regarding the outcome of the Halloween Parade. He thank businesses and families on the success.
- 3. Vice Chair Warren updated board on the Broadband Committee Meeting held on November 4th. Members attended a summit at Thomas College held by Island Institute. The next meeting will be December 2nd with a presentation by Consolidated Communications. January 6th meeting will have a presentation from Spectrum. Warren hopes more people will attend to become familiar with the process and get involved.

- 1. Public Works Foreman, Nicholas Upham, reported on the Public Works Department:
 - a. All equipment ready for Winter Operations;
 - b. last two weeks they have been working on putting Christmas lights up and will be ready to go by Thursday;
 - c. looking into the future budget he stated that he would like to try to fix some cross walk and sidewalks issues;
 - d. future budget season he would like to possibly upgrade some of the equipment. One truck is on list already but other equipment has either reached peak or past being needed to be replaced.
