Pursuant to Maine Law Title 8 MRSA § 443 through 449, and the powers granted by 30-A MRSA § 3001, the Town of Boothbay Harbor exercises its right through the Codes Of Boothbay Harbor, Chapter (73), to control the use, placement and noise generated by the use of pin ball machines, and the likeness thereof which are operated by a coin, token or otherwise and for the same purpose as what is commonly known as a pin ball or video machines. The Town of Boothbay Harbor divides these machines into three gropes or types listed below:

Chapter (73), Section (7) of the Codes of Boothbay Harbor, limits the number of amusement devises a place of operation may have at one time providing there is no more than three of any one type. The Board of Selectmen does reserve the right to permit additional machines for special events, tournaments, or civic events. It is the intent of the Codes to allow the "grandfathered" exception to the number of machines. Any exception or grandfathered machine shall require the normal fee per machine.
