Introductions of the Board of Selectmen.

TOWN MANAGER'S ANNOUNCEMENTS:

- 1. The last day to request an absentee ballot for the November 2, 2021, Referendum Election will be Thursday, October 28th. The clerk's office will be open from 8:30 a.m. to 4:30 p.m. Polls will be held at the Boothbay Harbor Fire Station from 8:00 a.m. to 8:00 p.m.
- 2. We are seeking nominations for the holder of the Boston Post Cane. The holder of the cane must be the oldest known resident and must reside in the Town of Boothbay Harbor for a minimum of 5 years. All nominations need to be received in the Town Clerk's Office by Friday, November 5th, 2021. A nomination form can be obtained from the Clerk's Office Monday through Friday from 8:30 a.m. to 4:30 p.m. or online at www.boothbayharbor.org.
- 3. State law requires you to license your dog in the town of residence of the owner by December 31st of each year. Each dog six months of age or older or spending more than 10 days within the state must be licensed. You may come into the Clerk's office Monday through Friday, 8:30 a.m. to 4:30 p.m., mail a current rabies certificate and check for the appropriate fee to 11 Howard Street, Boothbay Harbor Maine 04538, or register online at Maine.gov (search dog licensing) between October 15th and January 31st. FEES: Spayed/Neutered: \$6 per year, Not Spayed/Neutered: \$11 per year, Late Fees: \$25 per dog (Dogs not licensed by January 31st of each year).

- 5. The Sparkle Fireworks Display will be held on Saturday, December 4th at 7:30 p.m. for the Boothbay Lights Festival.
