The town is working with the Lincoln County Sherriff's Office to reconfirm the Memorandum of Understanding between the Lincoln County Sheriff's Office and the Boothbay Harbor Police Department. Sherriff Todd Brackett gave a summary of how the agreement works. The county and the town have always worked together when needed but with the short staff and hours that can't be covered within the Boothbay Harbor Police Department, the county will have designated hours to be in the area. Latter mentioned as soon as the details are finalized the public will be notified regarding any financial changes within the agreement. Both Sherriff Brackett and Boothbay Harbor's Chief Snyder summarized how they are trying to recruit officers to each department.

NEW BUSINESS:

A motion was made to approve the personal property write-offs in the amount of \$404.50 for 2017-2018. The motion was seconded and unanimously approved. Approved 4-0.
