# Town of Boothbay Harbor Application for Permit to Blast

**Please Note:** *No person shall engage in blasting or detonation of explosive materials within the Town of Boothbay Harbor without first obtaining a permit to conduct such operations from the Code Enforcement Officer. For the purposes of this Ordinance, blasting shall be defined as any activity entailing the use of explosives for the purpose of producing an explosion to demolish structures or to fragment rock for mining, quarrying, excavation, or construction.*

Application shall be filed at least 2 weeks prior to commencing blasting operations and shall contain the following:

3. A map/plan showing the location(s) and description of the proposed blasting activity (attach to this application).

4. Projected dates and times that work/blasting will occur: \_\_\_\_\_

5. A signage plan sufficient to warn all vehicles and pedestrians within 500 feet of the proposed blasting site that blasting will be occurring. The signs must be placed at least three days prior to blasting and include the approximate dates and times the blasting will occur.

6. Proof that the entity applying for the permit and performing the work is properly licensed by the State of Maine and in compliance with Title 25 M.R.S.A. Chapter 318, Subchapter 1: Explosives, and State Fire Marshall Rules, Chapter 31, and any other applicable State statutes and regulations.

7. Evidence that notice of the proposed blasting operation has been sent by United States Certified Mail, Return Receipt Requested to all landowners within 300' of the subject property of the application, as well as to all public utility companies (BRWD, BBHSD, CMP). Said notice shall indicate the location of the proposed blasting, approximate date and times that the blasting will occur and the name, address and telephone number of the entity that will actually perform the blasting operation. A copy of said notification together with a copy of the names and addresses of the landowners and a copy of the Return Receipts shall be filed with the Code Enforcement Office.

8. Proof that the blasting contractor has adequate liability insurance at a minimum amount of one million dollars to cover blasting operations.

Permit Fee: \$50.00

The Code Enforcement Officer shall act upon the Permit Application within ten (10) days of the receipt of a complete application form, fee and all supporting documentation as set forth above.
