## APPLICATION FOR OFF PREMISES SPECIAL AMUSEMENT PERMIT

Pursuant to Maine Law, Title 28-A § 1054, if you are providing off premise alcoholic beverages at a location other than your place of business, and if there is to be entertainment at that off premise location, you must obtain a special amusement permit from the municipality. Please provide the following information.

(1) There is a public notice requirement that the applicant must post for fourteen (14) consecutive days in the local paper before the Board of Selectmen can hold a public hearing to hear this request.
