TOWN MANAGER ANNOUNCEMENTS:

- 1. Flags have been brought to half-staff in honor of Warren Page, a long-time member of the Fire Department and Fire Chief. Condolences are given to his family after his passing.
- 2. Tax bills have been sent; the first installment is due September 18th with interest beginning the day after.
- 3. The selectmen's meeting in October falls on Indigenous Peoples' Day and is rescheduled for Tuesday the 15th.
- 4. Absentee ballots are available for request for the November 5th Presidential Election. Ballots will not be sent until 30 days before the election.

TOWN DEPARTMENT REPORTS: Lobster Cove and Atlantic Ave have had their final chip seal placed; there have not been any complaints.

SELECTMEN REPORTS: Latter, Rayle, and Tomko have met with a lighting design architectural firm regarding the replacement concept and resiliency for footbridge lighting and are expecting concepts soon.

FINANCIALS: Annual audit fieldwork has been completed. Taxes are at 31.6% collection year-to-date.
